SCHOOL MISSION STATEMENT

The mission of Mesquite Trails Elementary is to inspire and educate a school of leaders and learners to reach their full potential in a safe and positive environment.

SCHOOL PROFILE

Hesperia Unified School District is located in the high desert region of San Bernardino County, approximately 40 miles north of the Ontario/San Bernardino valley. More than 20,000 students in grades kindergarten through twelve receive a rigorous, standards-based curriculum from dedicated and highly qualified professionals. The district is comprised of 15 elementary schools which includes 3 choice schools. At the secondary level Hesperia has 3 middle schools, 3 comprehensive high schools, 1 alternative school, 2 continuation high schools, 1 community day school, and 6 charter schools.

Mesquite Trails Elementary is located in the Oak Hills area of Hesperia and serves students in grades Kindergarten through six. At the beginning of the 2009-2010 school year, 795 students were enrolled, including 5% in special education, 17% qualifying for English learner support, and 31% receiving free or reduced-price meals. Mesquite Trails Elementary achieved a 2010 Academic Performance Index (API) score of 834 and met 20/21 of the 2010 Adequate Yearly Progress (AYP) criteria. Mesquite Trails did not make AYP in the Hispanic Subgroup.

Parents are encouraged to volunteer in the classroom, library and school office, participate in school activities, and get involved in the decision-making process through school committees. Training for parent volunteers is offered twice a year; parents receive instruction on how to use work room equipment and policies. School Site Council, Family Night, Open House, Back to School Night, English Language Advisory Committee, Parent Education Night (by grade level), after-school programs and the Mesquite Trails Parent Club are great ways to get involved. English as a Second Language (ESL) classes are offered during the year for parents and family members. Parents are kept informed of school activities through newsletters, the school marquee, and school web site. The principal's monthly newsletter, The Eagle Express, features current events, mandatory announcements, test results, helpful hints for parents, suggestions for parent involvement and a two-month calendar of events. Some teacher's prepare weekly newsletters informing parents about classroom activities, upcoming programs, homework, and current areas of study. School administrators use Connect Ed, an automated telephone message system, to quickly contact parents at home for important information about school programs, committees, adult classes, or volunteering. Parents may contact their child's teacher or the school office at (760) 949-3149; parents who wish to volunteer should request a parent volunteer form and are required to obtain school board clearance.

Mesquite Trails Elementary provides a safe, clean environment for learning through proper facilities maintenance and campus supervision. Original facilities were built in 1998; ongoing maintenance and modernization efforts ensure facilities remain safe and up to date and provide adequate space for students and staff. CAMPUS SUPERVISION

Eight proctors, strategically placed in various areas of the campus, supervise students as they enter school grounds. Eight proctors provide supervision during the lunch recess; three proctors are stationed in the cafeteria and five supervise playground activities. At the end of the day, teachers, and school administrators monitor designated areas to ensure students leave campus in a safe and orderly manner.

CAMPUS MAINTENANCE

The custodial staff and district's maintenance department work together to ensure playgrounds, classrooms, and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. The principal and custodians communicate daily regarding maintenance issues and special projects; hand-held walkie talkies facilitate an efficient communication system and an immediate response to emergency situations. Once a month, the principal meets with the custodians and school office staff to discuss routines, upcoming events, and departmental needs.

One full-time day custodian and two full-time evening custodians are assigned to Mesquite Trails Elementary and work closely with the principal for routine maintenance, daily custodial duties, and special events. Every morning before school begins, the day custodian inspects facilities, ground areas, and school's perimeter for safety hazards and other conditions that need attention prior to students and staff entering school grounds. The evening custodians clean classrooms, desks, restrooms, school office and whiteboards, and are responsible for set up and take down of equipment and/or furniture for after-school meetings and evening events.

Mesquite Trails Elementary works closely with the district's Maintenance and Operations department (M&O) for larger projects, routine facilities maintenance projects, and school inspections. The most recent facilities inspection at Mesquite Trails Street Elementary took place on November 3, 2009. M&O employs a work order process that enables Mesquite Trails Elementary to communicate unscheduled maintenance needs, urgent repairs, or special projects. Emergency situations are regularly resolved in one hour or less.

III. Curriculum and Academics

Quality, Currency, and Availability of Textbooks and Instructional Materials (2010-11 School Year)

All textbooks used in the core curriculum throughout Hesperia Unified School District are aligned to the California Content Standards and Frameworks. Instructional Materials for grades K-8 are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. Instructional materials for grades 9-12 are standards-based and approved by the district's Board of Trustees. The district follows the State Board of Education's six-year adoption cycle for core content materials and the eight-year cycle for textbook adoptions in foreign language, visual and performing arts, and health. District textbook review and adoption activities occur the year following the state's adoption. Parents are invited to preview proposed adoptions at the district office for one evening and ten days prior to approval by the school board. In September 2009, the Hesperia Unified School District Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No.2009/10-14 which certifies as required by Education Code section 60119 (1) that textbooks and instructional materials were provided to all students, including English learners in the Hesperia Unified School District to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home to study, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts, (3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and (4) sufficient laboratory science equipment was provided for science laboratory classes offered in grades 9-11, inclusive.

The CMA is an alternate assessment that is based on modified achievement standards in ELA for grades three through nine, mathematics for grades three through seven and Algebra I and science in grades five, eight, and ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. On each of these assessments, student scores are reported as performance levels. Professional Development

This section provides information on how teachers and staff are trained for instructional improvement.

All professional development activities in Hesperia Unified School District revolve around the California State Content Standards and Frameworks and are research-based.

Certificated staff builds teaching skills and concepts through participation in ongoing training sponsored by the district and school site. Each school site identifies and coordinates its own staff development activities based upon individual student needs, school site plans, and the districts designated focus areas.

During the 2009-2010 school year, Mesquite Trails Elementary held one pre-service days covering Love and Logic strategies. This focus was selected by the principal, assistant principal, and Leadership Team. Training programs and topics are chosen based upon the school focus and student needs. The school used results from the California Standardized Tests and district benchmark assessments, teacher feedback, and findings from classroom observations to help identify Response to Literature as an area of focus. 9 hours of training was scheduled during the school year for grade level specific Response to Literature training.

The district supplements site-level professional development to follow up and support year-round and ongoing programs centered around the district's focus areas of reading and math. Supplemental professional development is offered throughout the school year on early student release days, during summer vacation, and on weekends. Staff development topics and focus areas are identified and selected based upon input from the district's Professional Development Committee, Principals' Roundtable, and teacher survey results. The Professional Development Committee meets once a year to review student test results from state and district assessments and review teacher survey needs. The Principals' Roundtable provides opportunities for school principals to discuss and share training needs based upon data analysis and classroom observations from each school site.

New teachers receive intensive support and training through the district's Induction Program and New Teachers' Academy. For beginning and out-of-state teachers, the district utilized the state Induction Program (formerly known as Beginning Teacher Support and Assessment), a statewide and state-mandated research-based program providing support and skill building through formative assessment and individualized support based on assessment.
